# P R E S I D E N T ' S   M E S S A G E



It is with humility, gratitude and excitement that I begin to serve as President of the St. Louis Chapter of the Missouri Society of Professional Engineers (MSPE). I, as a Civil Engineer, have always been fascinated by the important, even irreplaceable, role Engineers have played in the development of our modern world. I recently ran across a quote from David McCullough (author of *The Path Between the Seas* and *The Great Bridge* among others) that summarizes my view. He states, "Generally speaking, I've felt strongly for a long time that the civil engineers—the technicians of American life in the period after the Civil War before World War I—were greatly underrated." Organizations such as MSPE can play an important part in celebrating and representing the work of Engineers, and in the case of MSPE not just Civil Engineers but all Engineers.

Current events remind us our world and region face many challenges where Engineers should play an important part in the solution. I was reminded of the ubiquitous role Engineers can play in our day to day lives in all sorts of ways by the recent duck boat disaster on July 19 here in Missouri where 17 people unfortunately lost their lives. After this event I came upon an article on July 29 in the Post-Dispatch titled "Duck Boat Designer had no Engineering Credentials." The article discusses how modifications were made to the original duck boat design that may have contributed to the disaster. The article quotes one of the attorneys involved about the modifications and their being done by someone not qualified as an Engineer, "I just think, gosh, it would be like me practicing law without a license."

MSPE has responded too many of these challenges with exciting initiatives that provide a framework for thoughtful action. These initiatives include among others: P.E. Day, a P.E. Licensure Ceremony, and representing the interest of Engineers in the state capital during legislative sessions as outlined on-line at: <http://mspe.stlchapter.com/images/MSPELobbyistReport.pdf>. While our regional challenges MSPE is working to address may be more familiar to us they, unfortunately, are common elsewhere. So these challenges and MSPE's initiatives provide us an exciting opportunity to think globally and act locally.
